#### Attendance:

The EQIT 48-hour course of training is dependent upon participants fully engaging in course activities and discussions. Because of this, it is important that students attend all scheduled EQIT classes. However, there may be times when a student is unable to attend class due to an emergency or illness. In this event, students are expected to contact their EQIT instructor to inform them of an absence and to arrange to complete homework. Tardiness or early departure of more than 15 minutes will count toward total time absent. **Students may miss no more than 6 hours of class and still receive an EQIT certificate.** 

#### **Registration Fees:**

Participant fees represents 10% of the cost of the EQIT class and are utilized to support the training and activities. If your center is receiving funding through the Colorado Shines Quality Improvement Grant, these funds may be used for professional development, such as EQIT. No participant will be denied registration due to inability to pay the registration fee. Please contact the ECC of La Plata County for information about scholarships.
